"THAT, subject to the Companies Act 2016 ("Act"), the provisions of the Company's Constitution, the Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Securities") and the approvals of all relevant governmental and/or regulatory authorities, the Company be and is hereby authorised, to the fullest extent permitted by law, to purchase such amount of ordinary shares in the Company as may be determined by the Directors of the Company from time to time through Bursa Securities upon such terms and conditions as the Directors may deem fit and expedient in the interests of the Company ("the Proposed Share Buy-Back Authority") provided that:

- the aggregate number of shares purchased does not exceed ten percent (10%) of the total number of issued shares of the Company as quoted on Bursa Securities as at the point of purchase(s);
- the maximum amount of funds to be allocated by the Company pursuant to the Proposed Share Buy-Back Authority shall not exceed the aggregate of the retained profits of the Company based on its latest audited financial statements and/or the latest management account (where applicable) available at the time of the purchase(s);

- For the purposes of determining a member who shall be entitled to attend and vote at the forthcoming 16th Annual General Meeting ("AGM") of the Company, the Company shall be requesting the Record of Depositors as at 13 August 2026. Only a depositor whose name appears on the Record of Depositors as at 13 August 2026 shall be entitled to attend and vote at the meeting as well as for appointment of proxy(ies) to attend, speak and vote on his/her stead.
- The instrument appointing a proxy shall be in writing (in the common or usual form) under the hand of the appointor or of his attorney duly authorised in writing or, if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised. A proxy may but need not be a Member of the Company. There shall be no restriction as to the qualification of the proxy.

Explanatory Notes on Ordinary Business/Special Business:

- Item 1 of the Agenda**
To receive the Statutory Financial Statements for the Financial Year Ended 31 March 2026
This Agenda item is meant for discussion only as the provision of Sections 248(2) and 340(1)(a) of the Companies Act 2016 does not require a formal approval of the shareholders for the Statutory Financial Statements. Hence, this Agenda item is not put forward for voting.
- Resolution 1 – Dividend Payment**
With reference to Section 131 of the Companies Act 2016, a company may only make a distribution to the shareholders out of profits of the Company available if the Company is solvent. On 21 May 2026, the Board had considered the amount of dividend and decided to recommend the same for the shareholders' approval. The Directors of the Company are satisfied that the Company will be solvent as it will be able to pay its debts as and when the debts become due within 12 months immediately after the distribution is made on 30 September 2026 in accordance with the requirements under Section 132(2) and (3) of the Companies Act 2016.
- Resolutions 2 to 4 – Re-election of Directors**
In accordance to the Constitution of the Company, Mr. Chia Lik Khai, Mr. Ng Swee Weng and Datuk Wira Roslan Bin Ab Rahman (collectively as "Retiring Directors") are due for retirement as Directors of the Company and being eligible, have offered themselves for re-election at this AGM. Details of the Retiring Directors are set out in the Board of Directors' profile of the Annual Report 2026.

The Board has through the Nomination Committee, considered the assessment of the Retiring Directors as well as their adherence to fit and proper criteria as set out in the Directors' Fit and Proper Policy and collectively agreed that they met the criteria of character, experience, integrity, competence and time required to effectively discharge their respective roles as Directors, as prescribed by Paragraph 2.20A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("MMLR"). The Retiring Directors, who serve as Independent Non-Executive Directors, have also confirmed that they fulfil the independence criteria prescribed under the MMLR.
- Resolutions 5 to 10 – Payment of Directors' Fees and Benefits**
Pursuant to Section 230(1) of the Companies Act 2016, the fees of the directors, and any benefits payable to the directors of a listed company and its subsidiaries shall be approved at the general meeting.

The amounts of Directors' fees tabled for approval is based on the current composition of the Board which currently has 5 Non-Executive Directors ("NED"). The total amount of Directors' fees for the estimated period is RM516,000. There has been no revision to the Directors' fees previously approved by the shareholders at the 15th AGM of the Company held on 25 August 2025.

The Resolutions 5 to 9, if passed will authorise the payment of the Directors' fees to the NED on a monthly basis. The aforesaid Directors' fees shall continue to be in force until varied by resolution passed by the shareholders in a general meeting.

The proposed Directors' benefits for the Ordinary Resolution 10 consists of meeting allowance to the NED for their attendance at Board and Board Committee meeting(s) per meeting day. The total meeting allowance based on the estimated number of meetings scheduled for the period is RM80,000.

5. **Resolution 11 – Re-appointment of Auditors**

The Board had, at its meeting held on 21 May 2026, approved the AC's recommendation that shareholders' approval be sought at the 16th AGM on the re-appointment of KPMG PLT as the auditors of the Company, as set out under Resolution 11. The Board is satisfied with the suitability of KPMG PLT based on the quality of audit, performance, competency and sufficiency of resource that KPMG PLT had provided to BM GreenTech Group. KPMG PLT have indicated their willingness to be re-elected as auditors of the Company.

6. **Resolution 12 – Authority to Issue Shares and Allot Shares pursuant to Sections 75 and 76 of the Companies Act 2016**

The Ordinary Resolution 12 is proposed to seek for a renewal of the general mandate for the Directors to issue and allot shares pursuant to Sections 75 and 76 of the Companies Act 2016. If passed, it will empower the Directors of the Company from the date of the 16th AGM until the next AGM to allot and issue shares in the Company up to an amount not exceeding in total 10% of the total number of issued shares (excluding treasury shares) of the Company for the time being for such purposes as the Directors consider would be in the best interest of the Company. This authority will, unless revoked or varied at a general meeting, expire at the next AGM of the Company.

The Company has not issued any new shares under the general mandate for the issuance of new ordinary shares which was approved at the 15th AGM of the Company held on 25 August 2025 (hence, no proceeds were raised therefrom) and which will lapse at the conclusion of the 16th AGM.

The above renewal of the general mandate sought will enable the Directors of the Company to issue and allot shares, including but not limited to further placing of shares for purpose of funding investment(s), working capital and/or acquisitions, at any time to such persons in their absolute discretion without convening a general meeting as it would be both costs and time consuming to organise a general meeting.

7. **Resolution 13 – Proposed Renewal of Shareholders' Mandate for Recurrent Related Party Transactions of a Revenue or Trading Nature**

The Ordinary Resolution 13 is proposed and if passed, will enable the Company and/or its subsidiary company(ies) to enter into recurrent transactions involving the interest of Related Parties, which are necessary for the Group's day-to-day operations and undertaken at arm's length, subject to the transactions being carried out in the ordinary course of business and on terms not to the detriment of the minority shareholders of the Company.

8. **Resolution 14 – Proposed Renewal of Share Buy-Back Authority of up to Ten Percent (10%) of the Total Number of Issued Shares of the Company**

The proposed resolution, if passed, will empower the Directors to purchase the Company's shares through Bursa Malaysia Securities Berhad up to 10% of the total number of issued shares of the Company. This authority unless revoked or varied by the Company at a general meeting will expire at the conclusion of the next annual general meeting of the Company or within which the next annual general meeting after the date is required by law to be held, whichever occurs first. For further information, please refer to Part B of the Statement to Shareholders dated 22 July 2026.
